A. Please be advised that in addition to and in support of the FEMA flood zone designations noted above the property is subject to zoning regulation under the City's Zoning Code, Section 230 which establishes the Floodplain Overlay Zoning District. The Floodplain Zoning District Regulations may significantly restrict the use and development of your property. You are, therefore, encouraged to contact the Planning Department at (931) 520-5275 to verify the zoning of your property before making any property investments and/or improvements.

B. Flood Insurance is required for property located within Special Flood Hazard Areas (SFHA) FEMA Flood Zone A, AE, or AO if a Federally backed mortgage is secured for a structure. For more information on Flood Insurance contact any insurance agent in our community. Please note that this determination is based on the 100-year flood (a one percent chance of occurring in any given year) as shown on the current Flood Insurance Rate Map, provided by the Federal Emergency Management Agency. This letter does not make a determination that the referenced property will or will not be free from flooding or damage during such an event. A property not in a special flood hazard area may be damaged by a flood greater than that predicted on the Flood Insurance Rate Map or from a local drainage problem not shown on the map.
